Surat-395001 Gujarat since 1982 and has applied for permission for sanction of UG (BHMS) course with 100 seats and 37 seats in PG course in 07 subjects namely Homoeopathic philosophy 06seats Homoeopathic Materia Medica 06 seats. Homoeopathic Repertory 06 seats and Practice of Medicine 06. Pharmacy 06. Paediatrics 03. Psychitary 04 seats for the academic year 2024-2025. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

a) Miscellaneous

- College has not enabled the Adhaar Enabled Biometric Attendance system (AEBAS). The same may be implemented within one month of Time.
- Form 16 uploaded are not from traces portal. Same may be submitted for verification.

The above shortfalls observed in your College shall be rectified within a period of 30 and the compliance report shall be submitted to the MARBH.

Considering the above observations and facilities available. Medical assessment and Rating board has decided to issue conditional permission to C.D. Pachchigar Homocopathic Medical college, Near Anand Mangal Society Bhatar Road.

All admissions shall be made from NEET/AIAPGET — Qualified Candidates Only .It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the intake capacity of 100 UG seats and 37 PG seats shall be treated as All India Quota .The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government /NCH for the A.Y 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of the State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt /NCH for All India quota or the student admitted there under.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in subsequent year if the college found deficient in Compliance to MSR 2013 any time during the academic year.
